<b>Your right to withdraw consent</b>	Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.

<b>How long we will keep your personal data for</b>	We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you child/children are/is registered with <b>Actonians Cricket Club</b> as a member. 1 year after you cease to be a member of Actonians Cricket or play an active part in Actonians Cricket Club, we shall delete your personal data.
