TERMS AND CONDITIONS

1. Definitions

For the purposes of these Terms and Conditions:

- **Account** means collective information of your name, Year/Month of Birth, email address and phone number stored with KRCC for purpose of registration, verification, and management of funds.
- **Bet** means laying money on the successful prediction of the winning team of IPL2026.
- **Betslip** means a document or a form that records the details of a bet placed by a customer with KRCC. It usually shows the event, the outcome, the odds, the stake, and the potential winnings of the bet. A betslip is electronic and issued by KRCC via electronic means.
- **Customer** means person aged above 18 years and place the bet(s) on the winning team of IPL2026.
- **End date** means the last date on which the bets will be accepted by KRCC for this event. It will be closed at midnight UTC.
- **IPL2026** means “TATA IPL 2026 which will be the 19th edition of the Indian Premier League, a franchise Twenty20 cricket league in India, organised by the Board of Control for Cricket in India.”
- **KRCC** means “Knight Riders Cricket Club” affiliated with Northeast Scotland Cricket registered with Aberdeen City Licensing board under Gambling Act 2005.
- **Odds** means the chances of winning assigned to each team by KRCC, often represented by the different payouts you get for winning bets.
- **Return** means the amount of money the bettor stands to win if their bets are successful. This is calculated by multiplying the stake by the odds.
- **Stake** means the amount of money the bettor is risking on each individual team.
- **Team** means one of the ten teams participating in IPL2026 tournament.

2. Terms and Conditions

2.1 General

2.1.1. The betting for this event will be predicting the winning team of IPL2026.

2.1.2. Each bet costs £5.0/- (Pound Sterling). your maximum amount for a bet on a single team is restricted to £100/-.

2.1.3. Bets will be accepted up to the advertised END date closing midnight on that date.

2.1.4. All customers to contact KRCC using social media platform “WhatsApp” number **+44 7956 769032** and confirm your interest on placing the bet. Upon on verification that you are aged above 18, KRCC will place your bet and confirm with you by issuing the betslip number. Bets are not accepted in any other form (email, telephone, fax, etc.) and if received will be void, win or lose.

2.1.5. Customer cannot cancel or change a bet once the bet has been placed, betslip issued and confirmed.

2.1.6. KRCC reserves right to refuse the whole or any part of any bet request for any reason and at our sole discretion.

2.1.7. The ODDS on the individual bet will be decided by KRCC on the advertised END date. It will be announced on following the END date. The betslip will be re-issued with the declared odds on your bet.

2.1.8. The betting is based on the winning team of IPL2026. KRCC reserves the right to announce the winning betslip once the winners of IPL 2026 are officially announced in www.lplt20.com.

2.1.9. The official result is final for settlement purposes except where specific rules state the contrary. The presentation in this event is to be treated as the official result.

2.1.10. The official results based on the joint winners in IPL26 i.e. (Team 1 and Team 2) will distribute the final prize money as follows:

For example:

Table 1 below shows the customer betslip issued at the advertised END date whose bets, Stakes, Odds and Returns on two teams.

Table 1: Betslip Issued at the END Date

In circumstance, when the official results announces a joint winner, then customer betslip will be modified to distribute the prize money as shown in Table 2. The final returns will be recalculated with 50% of the ODDS declared on the END date as shown below:

2.1.11. RETURNS will be credited to the Customer's account following confirmation of the final result.

2.1.12. KRCC reserves the right to refuse/cancel any bet or part of a bet before the END date to make ambiguous bets void, without providing any justification.

2.1.13. KRCC reserves the right to cancel any bets from customers who place money in this event where they are in any way involved, as participants, referee, coach etc.

2.1.14. When the IPL2026 is cancelled, all related bets will be void automatically and STAKES will be refunded to the customer.

2.1.15. KRCC reserves the right to void any or all bets made by any person or group of persons acting in an attempt to defraud us.

2.1.16. KRCC reserves the right to void any bet that may have been accepted when the customer did not transfer sufficient funds to cover the bet.

2.2 Acceptance of Risk

2.2.1 By accepting these Terms, you are fully aware that there is a risk of losing money when involved in betting and you are responsible for any such loss. you agree that your use of our Services is at your sole option, discretion, and risk. In relation to your losses involved in betting, you shall have no claims whatsoever against KRCC or any partner, sponsors, respective officer bearers, volunteers, members, or employees of KRCC.

2.3 Protection of your Funds

2.3.1. All Customer Funds are held by KRCC in a segregated Customers' Funds bank account, separate from KRCC funds.

This means that Customer funds are protected in the event of KRCC's insolvency. This meets the Gambling Commission of Great Britain's requirements for the segregation of customer funds at the level: high protection.

2.3.2. KRCC is not a financial institution and any funds held in our account will not earn any interest in your favour.

Note: When you are involved in betting, you accept that there is a risk of losing money. We protect any money you deposit in our account, and keep it separate from the money We use to run our business.

2.4 Verification

2.4.1. you must be at least 18 years of age to place your bet for this event. Underage gambling is a criminal offence.

2.4.2. We are required to verify all of our customers' identities to comply with the requirements of our licences, our responsibility to prevent underage gambling and to prevent crime. you will not be permitted to involve in betting with KRCC until we have verified your name and age.

2.4.3. At registration, you are required to provide us your personal details, such as name and year/month of birth. All your data is used and protected as described in section 3.0.

We will do our best to verify your details based on the information you submit during the registration process. If we cannot do so you will be required to provide valid identification documents proving your identity & age. Acceptable identification documents include, but are not limited to:

- copy of a valid photographic identification document, such as a passport or driver's licence; and
- copy of a recent utility bill confirming residence, such as an electricity bill, telephone bill etc. (important: the utility bill must not be older than 3 months); and

- copy of a recent debit card / bank account statement (note: the account statement must relate to a financial method used and must not be older than 3 months).

2.4.4. If your details cannot be verified based on the documents provided, you must provide additional information until we are able to successfully verify your identity. and/or carry out such credit or other verification checks as we may require and/or are required by applicable laws, regulations, or the relevant regulatory authorities.

2.4.5. You agree to provide all requested documents in connection with these checks. Until we have received the requested documents and completed our checks to our reasonable satisfaction, we are entitled to restrict your account in any manner that we reasonably deem appropriate, including by preventing you from placing any STAKES. We may also ultimately suspend or close your account and/or pass on any necessary information to the relevant authorities.

To ensure the information we hold on you are always up to date, we may, from time to time, reperform our verification checks.

2.4.6. If we discover (after you've successfully register with us for this event) that you are under 18 years of age:

- your account will be closed;
- all transactions made via your account – including any winnings – will be voided;
- all funds deposited by you will be returned to you using the same payment method used for the deposit of such funds, wherever possible; and
- We may make a report to the relevant regulatory authority.

2.4.7. KRCC reserves the right to run credit checks with third party credit agencies on the basis of the information provided by you during registration.

Note: We're committed to providing a safe place for adults to involve in betting in this event. To do this we verify the identity of our customers.

3. Handling Data

3.1 How we use your personal data

3.1.1. We process your personal data for the purposes of

- Creating your account with KRCC

We use your personal data such as your name, year/month of Birth, mobile number and email address to help set up your account and, if necessary, to contact you (according to your contact preferences) via your registered contact information in connection with the management and operation of your account.

- Ensuring you are involved in betting responsibly;
- Identifying and verifying customers;

This includes the identification and verification of individuals under anti-money laundering legislation, ensuring customers are over 18 years of age to comply with responsible gambling rules and initiatives. To verify your age and the details that you registered with us, we may disclose such information to approved third parties with many safeguards in place. This is required to meet our legal obligations.

- Legal and regulatory obligations;

We are required to process and retain your personal data including but not limited to your name, account number, year/month of birth and location to prevent fraudulent activity, to detect and/or investigate crimes, and to ensure responsible gambling.

- Marketing;

We will use personal data such as phone number or email address to communicate for promoting future fundraising event, etc. you can choose not to receive marketing/promotional material at any time by contacting us.

3.2 How we store your personal data

3.2.1. KRCC is registered as a non-commercial society under the Gambling Act 2005. your personal data will be stored with KRCC in Aberdeen (UK). We store your data for period of six months from the date of registration. We will hold your personal data on our systems for as long as is necessary to comply our legal obligations in your jurisdiction, such those imposed by tax, gambling and associated laws.

4. Fraud and Collusion

4.1.1. Where there is evidence of a series of bets each containing the same (or very similar) selection(s) having been placed by or for the same individual or syndicate or individuals, KRCC reserves the right to make bets void and suspend relevant accounts. This rule applies to both settled and unsettled bets.

4.1.2. KRCC allows only one account per person. Any subsequent accounts opened under the same personal details that are found to be related to any existing account may be closed immediately and any bets will be voided at KRCC discretion. KRCC reserves the right to reclaim any winnings attained by these means and we reserve the right to withhold all or part of your balance and/or recover from your winnings that are attained by these means.

5. Payment Details / Withdrawals

5.1 Payment Details

5.1.1 Upon placing the bet and successful verification on your registration, the amount equal to your total STAKES to be transferred to KRCC account via bank transfer whose details are shown below;

Please quote the betslip Number in your reference during the transfer of funds. This facilitates to recognise the transfer of funds and issuance of betslip.

5.2 Withdrawals

5.2.1. No withdrawals/cancellation are accepted once the betslip is issued.

5.2.2. All withdrawals (wherever possible) will be processed back to the same payment method used to make a deposit on the account. Withdrawals may reflect as a single payment.

Please note that your payment method may impose fees for which we are not responsible.

5.3 Credit and Credit Cards

5.3.1. you may only place your bet with your available funds and KRCC does not offer credit.

5.4 No legal or tax advice

5.4.1. KRCC does not provide advice regarding tax and/or legal matters. Customers who wish to obtain advice regarding tax and legal matters are advised to contact appropriate advisors.

5.4.2. you are solely responsible for any applicable taxes on any prizes and/or winnings that you collect from KRCC.

5.5 Timescales and Security Measures

5.5.1. our aim is to process your RETURNS as quickly as possible. In doing so, we will consider any restrictions that may apply and will also adhere to the requirements of the Financial Action Task Force on Money Laundering.

5.5.2. We may need to take additional security measures to ensure that you are the rightful recipient of the funds. In these instances, copies of identification documents may be required before payment can be made. These measures are in place to prevent fraud and protect your money.

6. Prohibited Activities

6.1 What is a Prohibited Activity?

The following activities are prohibited (each a "Prohibited Activity"):

6.1.1. if you use our services, including your account, for any illegal purpose, activity or transaction (for example, money laundering, funding of terrorism, identity theft, misrepresentation of identity or identity fraud or payment fraud);

6.1.2. if we have reason to believe or suspect that you are involved in fraud, collusion or cheating of any kind in relation to your use of our services;

6.1.3. if you provide incorrect, misleading and/or misrepresentative information during the account registration or any subsequent verification process (except where you provide any incorrect or misleading information in order to pass relevant age-verification checks, which situation will be dealt with as described in section 2.4 above);

6.1.4. if we discover or reasonably believe that you are resident in, or you are located in, any jurisdiction other than the United Kingdom;

6.1.5. if the name registered on your account does not match the name on the bank account and/or debit card(s) linked to that account;

6.1.6. if your use our services other than for your own personal, non-commercial use;

6.1.7. if you have funded a third party for the purposes of betting in our event;

6.1.8. if you use a stolen, cloned or otherwise unauthorised payment method as a source of funds in connection with your account (including where you use stolen funds to fund your account using a payment method which is in your own name);

6.1.9. if you otherwise seriously breach these Terms.

6.2 Notifying others of Prohibited Activities

6.2.1. KRCC may inform the relevant authorities, regulatory bodies and/or sports governing bodies, other online service providers, banks, electronic payment providers or other financial institution of your identity and of any suspected Prohibited Activity on your part.

Note: We are committed to offering our customers a fair, safe place to involve in betting for this event. We don't tolerate illegal activity, cheating, misrepresentation of information or other types of unacceptable behaviour, and will also notify others if We think such activity has taken place.

7. Liability

7.1 You promise to pay

7.1.1. You agree that you will be responsible for any losses, expenses or other costs incurred by Us without limitation as a result of any breach by you of these Terms.

7.2 Limitation of Liability

7.2.1. Nothing in these Terms and Conditions excludes liability for:

1. death or personal injury caused by our negligence.
2. fraud (including fraudulent misrepresentation);
3. any breach by us of your statutory rights; or
4. any other liability which may not be excluded by applicable law.

7.1.2. Subject always to the paragraphs above in this section 7.1.1, KRCC shall accept no liability for any damages or losses which are deemed or alleged to have arisen out of or in connection with your use of our services.

7.2 Force Majeure

7.2.1. KRCC shall not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under the gaming contract that is caused by events outside our reasonable control.

Note: We're not liable for various things that are outside of our control or part of the nature of the services we provide.
