<b>Your right to withdraw consent</b>	Where you have given your consent to any processing of personal data you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we each had consent prior to your withdrawing it.	
<b>Location of your personal data</b>	We will each keep your personal data within the European Economic Area.	
<b>How long we will keep your personal data for</b>	We will normally keep your personal data for 2 years. After this time period your personal data will be securely deleted.
